4	Unacceptable	Supervision control measures written records must be in place. Try to reduce the risk further or abandoning event	
6	Unacceptable	Revisit procedures/assessment to reduce the risk to the lowest acceptable evaluation possible. Event <u>not</u> to go ahead at this level

Type of Incident	Score	Precautionary Measures
Slips/trips/falls		Recce in advance, avoid areas of concern, advise participants of possible hazards. Risk minimised
Restricted access		Walk to keep public areas at all times Risk minimised
Dog waste		All participants advised to clear up and dispose responsibly. Risk minimised
Dog bite		Dogs to be muzzled if required, new dogs to have muzzle available. Risk minimised
Deep water		All dogs on lead
Vehicle movements		Congregating in car park avoided. Risk Minimised
Weather		Be prepared for warm weather and ensure participants are made aware of caring for thier dog and walk is suitably paced. Risk minimised
Interaction with public		Make walkers aware of being considerate to others. Very important if venue is a busy public area if wather is fine. Not all members of the public are dog lovers so care to be taken not to overwhelm the park. Risk minimised

Standard pre-walk instuction to be given by walk co-ordinator (or nominated person). Walkers and/or their dogs not to enter restricted areas including but not restricted to childrens play areas, adjoining farmland, etc
